From the executive director

Dear Colleagues,

The future of IFSO as discussed in my presidential address last year in Sydney is developing quickly. The professional secretariat is up and running with, as can be expected, some starting problems. However, a good deal of those problems were not caused by Medconnect but by the transition of the publisher of our official journal Obesity Surgery from the office of Mervyn Deitel to Springer.

At this moment we hope that all problems are solved and all our members that subscribe to Obesity Surgery did receive the copies of the last issues. Further details on Obesity Surgery are in a separate paragraph.

Our current president and the executive board are also working on a program for accreditation of bariatric surgeon and bariatric centres in analogy to what has been achieved already in the USA (A.S.B.S.). Our president will address this issue separately.

Furthermore, and maybe most important the discussion has been opened to change the name of IFSO. Realizing that bariatric surgery in fact is metabolic surgery, as we have been reporting in our yearly IFSO congresses, it has become clear that we have to promote this to our colleague surgeons and internists world wide.

A preliminary proposal has been discussed in the executive board and this will be presented to the general council meeting in San Diego (A.S.B.S.) to bring it to vote at the general council meeting in Porto. More on this in a paragraph by Nicola Scopinaro.

From the president:

Dear Colleagues and Friends,

Surgery is now universally recognized as the only effective treatment for the morbidly obese patient with long-term sustained weight loss, while obesity comorbidities are either completely resolved or significantly improved postoperative following the significant excess weight loss.

However, this highly demanding and challenging surgical therapy necessitates the appropriate training and experience on the part of the surgeon. It is vital that the surgeon beyond the optimal theoretical knowledge also has the technical skills in both open and laparoscopic surgery, shows meticulous pre- and post-operative care, devotion and commitment to long-term patient follow-up.

Moreover, institutional commitment to the excellent multidisciplinary care of the morbidly and super-obese patient who run an exceptional surgical and anaesthetic risk, is essential to ensure the safe and effective performance of bariatric surgery. The necessary ancillary services, including specialized nursing staff, dieticians, psychologists, exercise advisors and a multidisciplinary bariatric medical team including surgeons, cardiologists, anaesthesiologists, ICU specialists and psychiatrists etc are of the utmost importance. Modern medical and surgical facilities such as operating room tables, instruments, furniture, radiology equipments etc capable to handle morbidly obese patients are of course essential tools for any institution that seeks to treat bariatric patients.

In an effort to improve the quality of service offered to bariatric patients worldwide, IFSO decided to form an international committee, with myself as the chairman, that will advise and endorse national and regional 'centres of excellence' programmes. The main task was the creation of guidelines that can be applied to different global areas and define the minimum acceptable surgeon's credentials and institutional requirements

for safe and efficient management of morbidly obese patients.

The committee has prepared a guidelines proposal with three main objectives:

- To help new centers willing to begin bariatric surgery with an acceptable degree of safety and efficiency.
- To advise existing bariatric institutions the way to improve their services offered to morbidly obese patients.
- Finally to set the requirements for a Bariatric Institution to advance to Centre of Excellence level, thus optimising patients' outcome.

The proposal will be discussed at IFSO's executive board interim meeting in San Diego 11-16 June 2007 and then distributed to the National Societies for acknowledgement. The final approval will occur in Porto by voting at the council meeting.

Latin American Chapter News

Second Latin American IFSO Congress of Obesity Surgery Cancún, México, April the 25th. To 28th., 2007

Blue sea, white beaches and the spectacular Great Melia Cancún Hotel were the scenery of the Second Latin American IFSO Congress of Obesity Surgery, held from April the 25th. To 27th., this year.

It is fair to say that all expectations were exceeded, we have the registration of 411 surgeons from 16 of the 19 Latin American countries, as well as colleagues from Portugal, Spain, Austria, France and Italy, and United States; we even had a surgeon from Cuba, who overcame serious difficulties to leave the island and attend the Congress.

The **Pre-Congress Course on Total Patient Care** had an impressive attendance, because it was necessary to open some walls in the room in order to accommodate over 200 physicians, psychologists, nutritionists, physical therapists and so on. Mrs. Elisabete Shiraga organized and coordinated the Course which stressed the importance of multidisciplinary group handling of obese individuals; the ultimate goal should be the creation of **Centers of Excellence** all over Latin America.

At the opening of the Congress, a **Plenary Session on Obesity: "Obesity, the Epidemic of the XXI Century"** was held with the presence of Dr. Luis Gerardo Castellanos, member of the Pan-American Health Organization (PAHO), Dr. Pablo Kuri Morales, Director of the Epidemiology from the Mexican Health Secretary, Dr. Arthur Garrido Jr., Past President IFSO, and Dr. Natan Zundel, President of the Latin American Association of Laparoscopic Surgery (ALACE); they showed the magnitude of the problem: in terms of sickness, associated diseases and costs of attention, obesity is more important than under nutrition in the Latin American region; besides, they stressed the role of bariatric surgeons not only as skillful specialists, but also as promoters of health habits among the population.

Other **Plenary Session** was devoted to "**Future of Obesity Management**", in which Dr. Miguel Herrera showed his research on **vagus nerve stimulation/blockage**, Dr. Roberto Rumbaut presented **robotic bariatric surgery**, Dr. Jesús Ojeda Valdés showed his experience in **Endoscopic Surgery**, and Dr. Gerardo Jiménez Sánchez, Director of the National Institute of Genomic Medicine, talked about the possibilities of **Genomic Medicine in Obesity**.

Four Lectures were given: Dr. J. Joaquín Resa lecture on **Obesity from Pre history to XXI Century**, Dr. Alberto Salinas on **From open to laparoscopic bariatric surgery**, Dr. Antonio Cascardo on **Bariatric attention on 360 degrees**, and Dr. Rafael Capella on **My experience on 400 bariatric procedures**.

The International Federation for the Surgery of Obesity was initiated in 1995 (Stockholm). The first official IFSO congress and founding meeting took place in Prague, Czech Republic 1996.

Nicola Scopinaro honoured by the American College of Surgeons (ACS)

Annually, the American College of Surgeons (ACS) bestows Honorary Fellowships on a limited number of world renowned surgeons of eminence, who are not citizens of the United States. This distinction is based on the recommendation of a Committee of senior, prominent members of the ACS. The list of nominees for this recognition is long, and only a select finite number are chosen to be so honored. To be selected the individual must be an acknowledged leader in his field, an outstanding clinician and technical surgeon, and a contributor to lasting knowledge by original research. An Honorary Fellowship is one of the highest awards made by the College.

At the Fall Clinical Congress of the College in October, 2007, the ACS will induct Dr. Nicola Scopinaro into Honorary Fellowship. Dr. Scopinaro - bariatric surgery pioneer, basic investigator, outstanding clinical surgeon, and the undisputed spirit of IFSO - is an Italian renaissance man of the 20th-21st centuries. He was born in Castagneto Carducci, Italy, on March 6, 1945, in the aftermath of World War II. When young Scopinaro was 13 to 14 years old, he took pleasure in debating with his father, who was Professor of Medicine at the University of Genoa. Dr. Scopinaro's academic career subsequently was also centered at the University of Genoa, from whose Medical School he graduated in 1969; he rose through the ranks to become Professor of Surgery in 1992. For most of his professional life, his career has been centered on the surgical therapy of morbid obesity.

After brief and very disappointing experience with the jejunoileal bypass, Scopinaro conceived the biliopancreatic diversion (BPD) procedure in 1973, and after two years of experimental physiologic studies in dogs on the various anatomic and functional as-

pects of the gastrointestinal tract, he performed the first BPD in humans on May 12, 1976. In April of 2000, he performed the first laparoscopic BPD. He has also performed and studied the Roux-en-Y gastric bypass procedure as a possible alternative, in certain situations, to the BPD.

Throughout this time period, Scopinaro continued in his physiologic studies of the gastrointestinal tract and has published extensively his theories on the relative metabolism of lean body mass, fat and viscera, and their individual influence on caloric consumption, weight loss, and weight stabilization. His clinical and investigative publications number more than 400. He is an ambassador for the BPD, and he is a frequently invited international speaker. He has maintained the largest series of BPD cases (nearly 3,000), and has published the longest-term results for this procedure.

Scopinaro has been well recognized for his work in bariatric surgery. He was Chairman of the First International Symposium on Obesity Surgery, held in Genoa in 1980, and of the nine subsequent annual meetings of this symposium. When the International Federation for the Surgery of Obesity was created in Stockholm in 1995, Scopinaro, a founding member, was elected its first President. After two years, Scopinaro left this office and was elected Honorary President of the Federation. He is also President of the European Chapter of IFSO, constituted in 2005.

The Honorary Fellowship in the American College of Surgeons demonstrates not only the international influence of Nicola Scopinaro but is a tribute to the field of bariatric surgery - the discipline to which Dr. Scopinaro has dedicated his life.

Who is Member of IFSO

The big advantage of IFSO Membership is reduced registration at IFSO sponsored meetings (much more than \$20) and a significant reduction in subscriptions to the Obesity Surgery Journal (for **IFSO members \$80 US when paid directly to IFSO**, also see www.obesitysurgery.com). ASBS members also receive the journal SOARD as part of their dues. Another advantage in the near future will be listing on the new IFSO website.

157 papers were presented by the attendants, as well as four Symposia: one on **Canabinoids** and its role on obesity and metabolic problems, another on **Gastric Sleeve**, one on **Gastric Band and Gastric Balloon**, and the last on **Metabolic Surgery**, mainly related to diabetes and its control by bariatric techniques.

The Mexican College of Obesity Surgery held its Assembly and the new Board of Directors was elected; it was decided to change the name of the College to **Mexican College of Surgery of Obesity and Metabolic Diseases A.C.**

Likewise, the **Latin American IFSO Chapter** held its Assembly and Dr. Arthur Garrido Jr. was elected President for the term 2007-2009; it was decided to hold the next Latin American Congress in **Chile, 2009**.

In summary, the Congress was a great success, the lectures, symposia, papers, etc, showed that Latin America has a great development on bariatric procedures, our Latin American colleagues are creative and hard working, and IFSO has in this region a great presence.

Interdisciplinary European Guidelines for Surgery of Severe (Morbid) Obesity.

Recently, Clinical Guidelines for treating severe obesity with bariatric surgery were simultaneously published in the Obesity Surgery and International Journal of Obesity.

It is for the first time in European history, that a group of key opinion leaders in the field of obesity, the Bariatric Scientific Collaborative Group (BSCG), was appointed by the major European scientific societies. Societies that lead this initiative were the International Federation for the Surgery of Obesity - European Chapter (IFSO-EC) and European Association for the Study of Obesity (EASO). The European Childhood Obesity Group (ECOG) participated in Guidelines creation as well.

Composition of the Scientific group was balanced with the presence of key opinion leaders in many specialties and from many European countries, and this allowed the coverage of key disciplines in comprehensive obesity management, as well as reflecting European geographical and ethnic diversity.

This joint BSCG Expert panel convened several meetings which were entirely focused on guidelines creation, during the past two years. There was a specific effort to develop clinical guidelines which will reflect current knowledge, expertise and evidence based data on morbid obesity treatment.

Moreover the BSCG clearly demonstrated and promoted advantages of close collaboration between obesity specialists and bariatric surgeons. BSCG developed „Interdisciplinary Guidelines on Surgery of Severe Obesity“ in order to provide physicians and surgeons with essential evidence-based data about bariatric surgery including information on indications, contraindications, pre-operative examinations, surgical techniques and long-term postsurgical fol-

low-up. A need for interdisciplinary approach and collaboration in preoperative examination and indication as well as in the long-term follow-up is emphasized. All of the Guidelines statements are matched with the best available literature evidence.

The BSCG report a set of interdisciplinary guidelines that they hope will improve the care of severely obese patients, and will set up and stress both the need and advantages of interdisciplinary approach to this serious disease of morbid obesity.

THREE PRE MEETING COURSES:

1. **Bariatric surgery basic course and Allied Health (5/6 September)**- This course provides an overview of the fundamentals of bariatric surgical practice management, covering a variety of topics related to the pre- and post-operative care of the bariatric surgical patient and although it is applied to allied health care professionals, it is useful as an update in management practice for the physician, for surgeons new to the field and a very good review for the experienced bariatric surgeon. 2. **Advanced bariatric course** - This course is applied primarily to bariatric surgeons that are already on the field, it encompasses a broad spectrum of topics regarding the surgical techniques and care of the bariatric patient. The problems that worry all about the best technique, how the best way to do it and solve their problems, and to whom they should be applied will be discussed. - The second round table will take place at 07/09 consists about **endoluminal surgery on the treatment of obesity**, where all the new techniques of endoluminal treatment of obesity will be rolled.
- The third round table will be also on 07/09 consisting about **redo surgery**.
- The fourth round table will be held at 08/09 and consists about the **results at long term (consolidation of results)** of the several techniques used on treating severe obesity

International Federation for the Surgical treatment of Obesity and Metabolic Disorders

THE REASONS WHY IFSO SHOULD CHANGE ITS NAME

There is a right time for everything, and this also applies to the metabolic consequences of bariatric operations. Walter Pories and myself started almost 15 years ago describing and publishing the amazing specific effects, independent of weight changes, of gastric bypass on type 2 diabetes mellitus and of biliopancreatic diversion on all the major components of what is called today the metabolic syndrome. Simply, it was not the right time yet. We still had problems in having the concept of surgical treatment for morbid obesity accepted by our medical colleagues, so let us imagine if any endocrinologist could have even listen to anybody talking about surgical therapy of diabetes.

In the last years, mainly thanks to the enormous impulse given to obesity surgery by the introduction of adjustable silicone gastric banding, which made obesity surgery, especially in Europe, widely acceptable for hundreds of surgeons and thousands of patients who otherwise would have never considered it, also our medical counterpart started becoming interested to this field. Therefore, today the time is mature for a further big step forward.

We had the first timid meeting on the topic of the specific effects of bariatric operations on type 2 diabetes mellitus in Strasbourg on June 2006, thanks to the initiative of Francesco Rubino. He was soon joined by David Cummings, Lee Kaplan and Philip Schauer, with whom he organized a second, more official meeting in Boston on October of the same year. On that occasion, it was decided a big international meeting to be held on March 2007 in Strasbourg, which was eventually changed with Rome, where for the first time we dared to use the term Diabetes Surgery Summit.

On last December, 2006, I had the honor of being invited at the superb Annual Meeting of the Brazilian Society for Obesity Surgery, and on that occasion I realized how much and how rapidly the more or less conscious desire for a new discipline was growing in many people's minds. I had the feeling that in less than one year, much more than surgery for obesity we would have talked about surgery for type 2 diabetes in particular, and metabolic syndrome in general.

I talked with Arthur Garrido, and we imagined that in a relatively short time a great number of "metabolic surgeons" would have searched for a house, and that, not finding any, they would have built a new one for themselves. We thought that that was the right time for our Federation to change name, in order to offer a house to those newly born surgeons, thus preventing them to get together without the long experience of the old good obesity surgeons, thus probably going to make the same long series of mistakes that we started forty years ago with obesity surgery.

As soon as I was back to Genoa I wrote the IFSO Executive Council Members suggesting this change and explaining the reasons for this. As I expected, I did not encountered any resistance, with the exception of Henry Buchwald, who, with the usual wisdom that characterizes him, wanted to think a while about it, and is today even more convinced than myself.

There was obviously a thick discussion about the new name, but it did not take a long time to reach a general agreement on "[International Federation for the Surgical treatment of Obesity and metabolic disorders](#)". This would allow us to put the necessary emphasis on the new topic, still keeping our old logo, which should never be changed.

On the occasion of the Rome Diabetes Surgery Summit it was also proposed to set up a new Committee for the "Metabolic Surgery", and to call up Francesco Rubino, the official originator of this new discipline, to chair this Committee. These are the two proposals that the IFSO General Council in Porto will be asked to approve.

Sooner or later someone will possibly try to create an autonomous international society for metabolic surgery, and this will certainly be his right. What is important is that this fascinating but still weak and not fully oriented discipline have its difficult times of childhood and adolescence spent under the old, good, wise, big umbrella of IFSO.


